To sponsor scholarship for the promising students & to encourage them in every possible way to pursue their studies.





6 Member of the :  
Board of Trust

The Board of Trustees hereinafter referred to as the Board shall be constituted by all the Trustees named above including the Founder Trustees (the Settlers) Smt. Ragini Rai will be the Chairman of the Board of Trustees and Sri Ranjeet Rai will be the vice chairman.

In case of death or retirement of any member or this refusal to act as a member of the Board of Trustees the settlers will have power to appoint any other person as a member of the board with same powers and obligations in consultation and approval of the trustees.


8 Period of Office : i)


The Board of Trustees shall function for 3 three years and in case of death and retirement or refusal of any members of the Board of Trustees within the period the settlers in consultation with the remaining members of the Board will appoint any person as a members of the Board of Trustees for three years , where after the membership of the nominated members shall automatically expires where after the settlers shall nominate any members or another person as a Board of Trustee which may include a old member also.

ii) The members of the Board of Trustees shall be nominated for a period of three calendar years expiring with 31st December of the 3 years Period.

iii) The Members of the Board of Trustees as also the trustees except settlers shall vacate office on 31st December after every 3 years and new Board of Trustees shall assume office on the 1st January after 3 years.

- c) To undertake carry out, promate sponsor, assist and aid directly or in any other manner for the uplift promotion and growth of education cultural activities among the students people of Daltonganj and the State of Jharkhand and of any where else either in its own name or on behalf of any other person, company or organizations.





- h) To Solicit , obtain or accept subscriptions donations, grants in aid, gifts & endowment bequest from Trustees as also movable or immovable property of any kind from Government Municipalities other local or public bodies co-operative societies or other person provided that if any one or more of the objects specified in the clause are held not to be the objects of public charitable natures as understood under the income Tax Act or any statutory modification or enactment thereof for the time being in force the Trustees shall not carry out such object or objects nor shall apply trust fund or objects but the validity of Trust for public charitable purpose shall not be affected on such account In this instrument the expression charitable purpose or Public Charitable Purposes public Chartiable nature or all similar words shall have the same meaning as assigned to them under the income Tax Act 1961 or any statutory modification or enactment thereof.




11. Power of the :



The Trustees shall have all the powers subject to the various Trust Acts for the time being in force and the Trustee shall also be entitled to exercise all the powers & do all acts and things in relation to the Trust fund and Trust Property as a owner of the properties in entitled to do in good faith and according to law to carry on aims and objects of the trust. The Board of trustees shall have the following powers :-

- a) To collect funds by way of contributions, donations, gifts, endowments grants and the like whether conditional or otherwise for the purpose of the Trust.
- b) To acquire to develop to build upon or alter and to use for the objects of the trust any property whether moveable or immovable whether freehold or lease and license or ownership flat basis.
- c) The Board of Trustees in the interest of the Trust and to carry out its aims and objects may decide to transfer any property in part or whole and the valuation for such transfer shall be decided by the founder trustees called the settlers and they will have the right to execute and do every things to effect the transfer and to invest the amount for the ends of the Trust or donate the amount to any other charitable trust or Institution engaged in similar charitable activities.
- d) To invest the monies of the Trust not immediately required for application to the objects of the trust in such funds securities or deposit as are permitted by the law for the time being in force.
- e) To employ staff and to incur establishment for the purpose of carrying out the objects to the Trust.

- : f) To open one or more Bank accounts in any scheduled Bank or Banks and such accounts shall be operated under the joint signatures of any two amongst Treasurer and Chairman or Vice Chariman.
- g) The Trustees shall apply & portion of the Trust Fund or Trust Property for attending any objects outside India or for doing any charity outside India or for purpose on such terms and conditions as considered fit and by the trustees and otherwise to receive money.
- h) To borrow or raise money for the Purpose of the Trust on terms and Conditions as may be considered proper by the Board of Trustee and the Trustees may authorize any of the members of the Board to execute necessary papers and documents which shall be fully binding on the Trust in all respect.




- m) To draw make accept endorse discount the cheques notes or other negotiable instruments.

- u) To make rules and regulations in connections with the Board of Trustees and control of the Trust.




